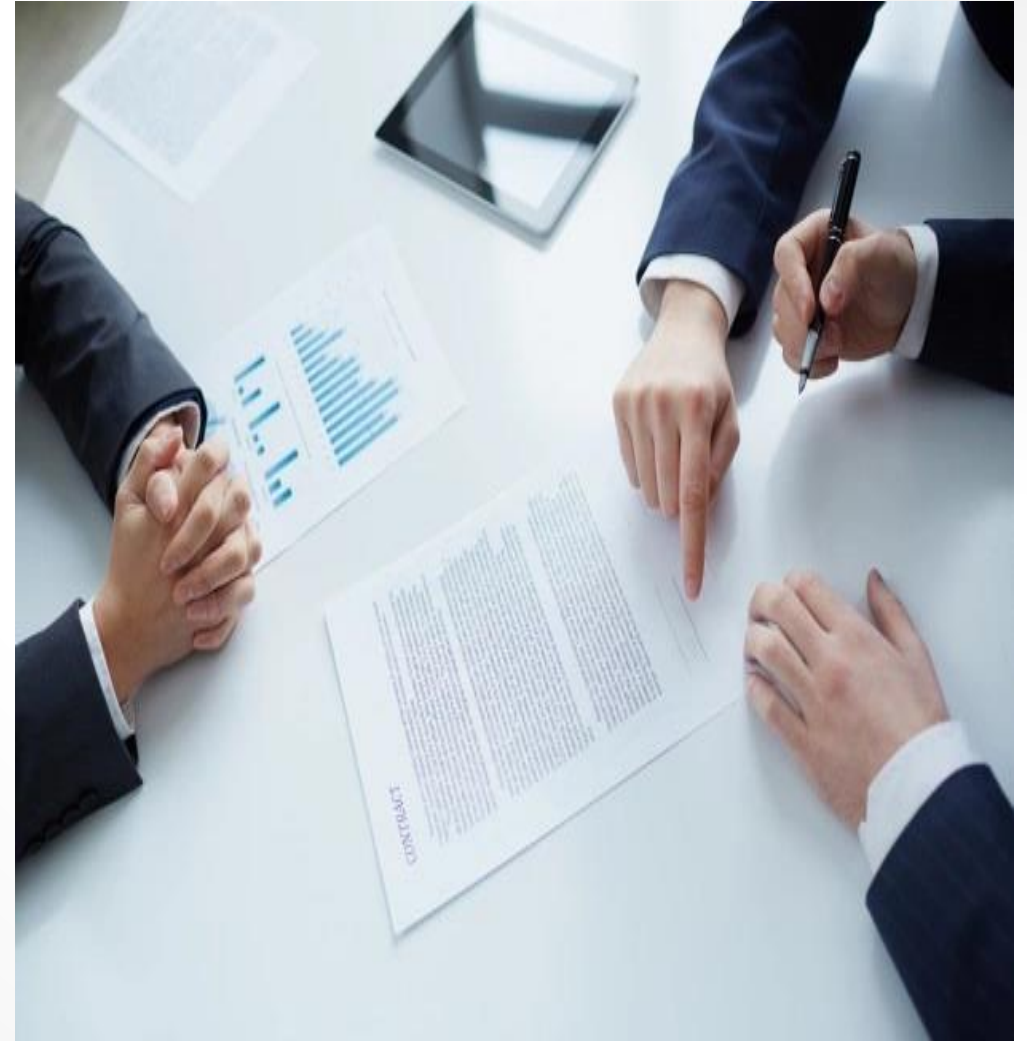
Team
